**Date and place of arrest:** 17<sup>th</sup> April 2014, in Qazax

**Charges:** Resisting the police during a crackdown on a private religious meeting

**Article of the criminal/civil/administrative code:** Administrative Code Article 310.1

**Court decision:** Sentence of 7 days imprisonment

**Other information:** He was arrested during a police raid in a private home that led to the confiscation of 185 “illegal” books promoting writings of Said Nursi.

## **Jehovah's Witnesses**

### **Kamran SHIKHALIYEV**

**Age:** 18 years

**Date and place of arrest:** 1<sup>st</sup> April 2014, Baku

**Charges:** Evasion of military service

**Statement of defendant:** Performing military service is incompatible with his faith.

**Article of the criminal/civil/administrative code:** Criminal Code Article 335.1

**Court decision:** Sentenced on 16 April 2014 to one year in a disciplinary unit of the military

**Statement of the defendant:** Performing military service is incompatible with his faith.

**Place of detention:** Military Unit No. 704 in Lenkaran

## **AZERBAIJAN/ NAGORNO-KARABAKH**

Since the end of the Nagorno-Karabakh War in 1994, Azerbaijan has not exercised power over about 20% of its territory, including Nagorno-Karabakh and several districts, which were occupied by the Armenians before this region unilaterally declared its independence under the name of the Nagorno-Karabakh Republic. This self-proclaimed state is not recognized by any country. Several UN resolutions recognized the secessionist territories were part of Azerbaijan. For 20 years, the OSCE Group of Minsk is unsuccessfully trying to solve this sovereignty issue.

**Artur AVANESYAN**

**Age:** 19 years

**Date and place of arrest:** 14<sup>th</sup> July 2014, in Yerevan (Armenia)

**Charges:** Evasion of military service

**First court decision:** On 30<sup>th</sup> September 2014 he was sentenced to 30 months in prison by Martakert, Nagorno-Karabakh First Instance Court.

**Article of the criminal/civil/administrative code or law:** Criminal Code Article 347 Part 1: "Evasion from regular military or alternative service call-up, training exercise or mobilization, without any order defined by Legislation as grounds for exemption, is punished with arrest for a maximum term of two months or imprisonment for a maximum term of three years"

**Statement of the defendant:** Performing military service is incompatible with his faith

**Other information:**

**Karen HARUTYUNYAN**

**Age:** 18 years

**Date of arrest:** 30<sup>th</sup> November 2011 in the town of Askeran, central Karabakh

**Charges:** Evasion of military service

**Statement of the defendant:** Performing military service is incompatible with his faith

**Place of detention:** Shusha Prison, near capital city of Stepanakert

**First court decision:** 30<sup>th</sup> December 2011, sentenced to 30 months in prison by the Askeran District Court

**Article of the criminal/civil/administrative code or law:** Criminal Code Article 327, Part 1: “Evasion from regular military or alternative service call-up, training exercise or mobilization, without any order defined by Legislation as grounds for exemption, is punished with arrest for a maximum term of two months or imprisonment for a maximum term of three years”

**Other information:** The Nagorno-Karabakh Republic is a de facto independent but unrecognized state. The territory is internationally recognized as part of Azerbaijan, although the latter has not exercised power over most of the region since 1991. Since the end of the Nagorno-Karabakh War in 1994, the territory has been under military control of Armenia.

## **BHUTAN**

### **Christians**

**M.B. THAPA (aka Lobzang)**

**Age:** 56 years

**Date and place of arrest:** On 5<sup>th</sup> March 2014 in Khapdani village (Dorokha)



**Charges:** Conducting a religious meeting without prior approval, showing a film without certificate of approval from the concerned media authorities and collecting 'illegal funds'

**Article of the criminal/civil/administrative code or law:** Article 71 of the Civil Society Organization Act of Bhutan, which outlaws raising funds for activities “in contravention of the laws of the country” and without prior permission

**Last court decision:** In September 2014, M.B. Thapa was sentenced to two years and four months in prison or a fine of 98,800 Ngultrum (\$1630).

**Duration of the detention:** 49 days after his arrest in March without formal charges

**Date of release:** Released on bail on 22<sup>nd</sup> April 2014

## **Tandin WANGYAL**

**Age:** 30 years

**Date of and place of arrest:** On 5<sup>th</sup> March 2014 in Khapdani village (Dorokha)

**Charges:** Conducting a religious meeting without prior approval, showing a film without certificate of approval from the concerned media authorities and collecting 'illegal funds'

**Article of the criminal/civil/administrative code or law:** Article 71 of the Civil Society Organization Act of Bhutan, which outlaws raising funds for activities “in contravention of the laws of the country” and without prior permission

**Last court decision:** On 10<sup>th</sup> September of 2014, Tandin Wangyal was sentenced to three years and eleven months in prison by the Court of Dorokha, Samtse District

**Duration of detention:** 49 days after his arrest in March without formal charges

**Date of release:** Released on bail on 22<sup>nd</sup> April 2014. After he was sentenced on 10<sup>th</sup> September, he was immediately released on bail without being detained.

# CHINA

## Protestants

### **Pastor XU Yonghai and 11 other Protestants**

**Date and place of arrest:** 24<sup>th</sup> January 2014, in Tongzhou, Beijing

**Charges:** Participation in demonstrations and illegal assembly

**Statement of defendants:** Gathered to study the Bible at the home of pastor Xu Yonghai's house

**Place of detention:** Beijing Municipal First Detention Centre

**Duration of detention:** Pastor Xu and 11 others were detained for at least 3 weeks. Pastor Xu has been under surveillance for several years in connection with pro-democracy activities and supporting unregistered Christian groups .He was previously sentenced for the same reasons.

### **REN Zhimin and SUN Yuefen**

**Place of residence:** Provinces of Mongolia, Heilongjiang and Baishan

**Date and place of arrest:** 1<sup>st</sup> August 2012 in the hamlet of Zhongxinbu, Shumugou village, Horqin Right Front Banner, in the city of Ulanhot

**Charges:** Using a cult to interfere with law enforcement and engaging in illegal evangelism

**Article of the criminal/civil/administrative code or law:** Clause 3 of the "Supplementary Stipulations on Re-education through Labour," State Council Document No. 56 (1980)

**Statement of the defendants:** Providing medical services in rural areas of Inner Mongolia

**Court decision:** On 1<sup>st</sup> September 2012, Ms. Sun and Ms. Ren were sentenced to two years in a re-education through labour camp by the Reeducation through Labour Management Committee of Hinggan League.

**Place of detention:** Horqin Right Front Banner police station

**GONG Shengliang, HU Yongand, XU Fuming** (Evangelical South China Church)

**Charges:** Belonging to a forbidden cult

**Statement of the defendants:** Leaders of the unregistered South China Church

**First court decision:** December 2001, sentenced to death for “using a cult to undermine enforcement of the law”

**Last court decision:** In September 2002, a retrial sentenced Gong Shengliang, Xu Fuming and Hu Yong to life imprisonment.

**CUI Jiaxing and YANG Rongli** (Linfen Church)

**Place of residence:** Linfen City

**Date of Arrest:** 13<sup>th</sup> September 2009

**Charges:** Illegally occupying farmland and disturbing transportation order

**Statement of the defendants:** Defending their church building from destruction by the authorities on 13<sup>th</sup> September 2009 (Fushan Church in Linfen City, Shanxi Province).

**Place of detention:** Yang Rongli is in Taiyuan Detention Centre, the others at Yicheng County Detention Centre.

**Last court decision:** On 25<sup>th</sup> November 2009, Yang Rongli was sentenced to seven years in jail and fined 30,000 Yuan; and Cui to five years and a half with a 50,000 Yuan fine. In 2010, an appeal was rejected by the Linfen courts.

**REN Lacheng and LI Wenxi (brothers)**

**Place of residence:** Beijing

**Date and place of arrest:** 17<sup>th</sup> June 2013, Taiyuan, Shanxi province

**Charges:** Illegally operating a business

**Statement of the defendant:** Helping to open a Christian bookstore

**First court decision:** On 17<sup>th</sup> June 2013, Xiaodian district court of Taiyuan sentenced Wenxi Li to two years and Lacheng Ren to five years in prison.

## **Yan BEIBEI**

**Age:** 23 years

**Date and place of arrest:** 16-17<sup>th</sup> November 2013, Nanle County Christian Church (a church registered with the official “Three-Self Patriotic Movement”), Henan province

**Charges:** Fraud and disruption of public order

**Statement of the defendant:** Refusal to surrender Church property to the authorities

**Place of detention:** Nanle County Detention Centre

**Date of release:** 11<sup>th</sup> June 2014

## **CAO Xia**

**Date of birth:** 15<sup>th</sup> February 1961

**Place of residence:** Daying Village, Rendian Town, Ye County, Henan Province

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting in her home

**Last court decision:** Three and a half years in prison

**Place of detention:** Pingdingshan Detention Centre

## **GONG Bangkun (Evangelical South China Church)**

**Charges:** Belonging to a forbidden cult

**Statement of the defendants:** He is the leader of the unregistered South China Church

**First court decision:** Sentenced to death for “using a cult to undermine enforcement of the law” in December 2001

**Last court decision:** In September 2002, Gong Bangkun was given a 15-year prison term.

**Other information:** Bankun is the founder of China’s biggest network of Evangelical house churches.

## **HAN Hai**

**Date of birth:** 16<sup>th</sup> April 1953

**Place of residence:** Yeyi Town, Ye County, Henan Province

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Seven and a half years in prison

**Place of detention:** Ye County Detention Centre

**Other information:** Previously, he was administratively detained twice and also sentenced to imprisonment in a labour camp for three years.

## **HU Linpo**

**Date of birth:** 27<sup>th</sup> November 1962

**Place of residence:** Qianwang Village, Xiantai Town, Ye County, Henan Province

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Seven years in prison

**Place of detention:** Ye County Detention Centre

**Other information:** Hu is from Singapore and is the house church's main preacher. Hu was previously detained for 30 days in 1989.

## **LAI Yiwa**

**Charges:** Printing 1,600 copies of Almighty God (also known as Real God or Eastern Lightning) publications in his home and distributing them to others

**Statement of the defendants:** Printed copies of Almighty God in his home

**Last court decision:** April 2013, seven years in prison

**Place of detention:** Beijing Prison

## **LI Dan**

**Date of birth:** 10<sup>th</sup> August 1988

**Place of residence:** 41, Row 6, Chaohua Street, Zhengmei Group, Zhengzhou, Henan

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Seven and a half years in prison

**Place of detention:** Pingdingshan Detention Centre

**Other information:** She was involved in copying CDs.

## **RUILING Fan**

**Age:** 23 years

**Date and place of arrest:** 16-17<sup>th</sup> November 2013, Nanle County Christian Church (a church registered with the “Three-Self Patriotic Movement”), Henan province

**Charges:** Fraud and disruption of public order

**Statement of the defendant:** Refusal to surrender Church property to the authorities

**Place of detention:** Nanle County Detention Centre

**Date of release:** 11<sup>th</sup> June 2014

## **WANG En**

**Date of birth:** 28<sup>th</sup> October 1988

**Place of residence:** Xiali Town, Ye County, Henan Province

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Three years in prison

**Place of detention:** Ye County Detention Centre

## **YANG Lianbin**

**Date of birth:** 19<sup>th</sup> November 1989

**Place of Residence:** Zhengzhou

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Three years in prison

**Place of detention:** Ye County Detention Centre

## **YIMITI Alimujiang** (Christian ethnic Uyghur)

**Date of birth:** 10<sup>th</sup> June 1973

**Place of residence:** Tianshan District, Urumqi, Xinjiang

**Date of arrest:** 12<sup>th</sup> January 2008 arrested and detained; 20<sup>th</sup> February 2008 formally arrested

**Charges:** Suspicion of inciting subversion of state power, leaking state secrets. Since 2002 engaging in activities of illegal religious infiltration, including preaching Christianity among the people of Uyghur ethnicity, distributing religious materials and converting to Christianity

**Statement of the defendants:** Working for a British-owned company (Jirehouse) and leading a house church ministry in Kashgar with his wife

**Place of detention:** On 12<sup>th</sup> April 2010, he was transferred to No. 3 Prison of Xinjiang in Urumqi

**First court decision:** On 6<sup>th</sup> August 2009, Kashi District Intermediate Court secretly sentenced Yimiti to 15 years in prison for “illegally providing state secrets to foreign nationals”

**Final court decision:** February 2011, the Higher Court of Xinjiang upheld the ordinal sentence of 15 years.

**Other information:** On 12<sup>th</sup> September 2008, the United Nations Working Group on Arbitrary Detention ruled in its No. 28 document that Alimujiang’s arrest and detention had been arbitrary.

### **Pastor ZHANG Shaojie**

**Age:** 49 years (Pastor Zhang Shaojie)

**Date and place of arrest:** 16-17<sup>th</sup> November 2013, Nanle County Christian Church (a church registered with the “Three-Self Patriotic Movement”), Henan province

**Charges:** Fraud and disruption of public order

**Statement of the defendant:** Refusal to surrender church property to the authorities

**Last court decision:** 12 years in prison, fined 100,000 RMB (approximately £9,400)

**Place of detention:** Nanle County Detention Centre

### **ZHANG Mian**

**Date of birth:** 13<sup>th</sup> May 1975

**Place of residence:** Daying Village, Rendian Town, Ye County, Henan Province

**Date and place of arrest:** 14<sup>th</sup> April 2012

**Charges:** Organising a cult to undermine law enforcement

**Statement of the defendant:** Attending a religious meeting

**Last court decision:** Three years in prison

**Place of detention:** Pingdingshan Detention Centre

**Other information:** She owns the residence where the group meets.

### **ZHIJUN Zhao**

**Age:** 23 years

**Date and place of arrest:** 16-17<sup>th</sup> November 2013, Nanle County Christian Church (a “Three-Self Patriotic Movement” church), Henan province

**Charges:** Fraud and disruption of public order

**Statement of the defendant:** Refusal to surrender Church property to the authorities

**Place of detention:** Nanle County Detention Centre

**Date of release:** 11<sup>th</sup> June 2014



## Catholics

### **TIAN Dalong and another priest**

**Age:** In their 40's

**Place of residence:** Qinyuan City, Hebei Province

**Date and place of arrest:** Early October 2013

**Statement of the defendants:** Organised catechism classes for adults

**Place of detention:** Police barracks in Baoding

**Other information:** He has been missing since his arrest.

### **Msgr. Cosma SHI Enxiang, underground bishop of Yixian (Hebei)**

**Date of birth:** 1932

**Date and place of arrest:** 13<sup>th</sup> April 2001 in Beijing

**Charges:** Unknown

**Court decision:** Unknown

**Place of detention:** Unknown

**Other information:** Msgr. Shi Enxiang has intermittently suffered long periods in prison and house arrest from 1957 until 1980. His current whereabouts are unknown.

### **Fr. CUI Tai, underground priest of the diocese of Xuanhua (Hebei)**

**Date and place of arrest:** He was taken away by staff of the Religious Affairs Bureau on 22<sup>nd</sup> June 2011.

**Charges:** Unknown

**Court decision:** Unknown

**Place of detention:** Unknown

**Other information:** Fr. Cui disappeared while in police custody on 22<sup>nd</sup> June 2011 after members of the government's Religious Affairs Bureau dragged him away. Since that time there has been no information on his whereabouts.

**Fr. GAO Jiangping and another priest**

**Place of residence:** Diocese of Suyian, Inner Mongolia

**Date of arrest:** 31<sup>st</sup> January 2012

**Charges:** The Diocese of Suiyuan does not exist according to the Chinese government, as it is part of the illegal underground Catholic Church.

**Statement of the defendant:** Incompatibility between the allegiance to the regime and his loyalty to the Roman Catholic Church and the Pope

**Other information:** He has been missing since his arrest.

**Fr. LIU Honggen, underground priest of the diocese of Baoding (Hebei)**

**Date and place of arrest:** 27<sup>th</sup> December 2006

**Charges:** He refused to join the *Catholic Patriotic Association*.

**Court decision:** Unknown

**Place of detention:** Prison of Qingyuan

**Fr. Joseph LU GENJUN, vicar general of the underground diocese of Baoding (Hebei)**

**Date and place of arrest:** Disappeared in police custody 17<sup>th</sup> February 2006

**Charges:** Unknown

**Court decision:** Unknown

**Place of detention:** Unknown

**Other information:** Fr. Lu has been detained intermittently for many years, including three years of "re-education through labour" after being accused of having conducted illegal missionary activities that undermine the social order (he would not join the *Catholic Patriotic Association*). He is presently missing.

**Thaddeus MA Daqin (Bishop of Shanghai)**

**Charges:** Resignation from the state-controlled *Chinese Catholic Patriotic Association (CCPA)*

**Statement of the defendant:** Incompatibility between the allegiance to the regime and his loyalty to the Roman Catholic Church and the CCPA

**Place of detention:** Since 7<sup>th</sup> July 2012 he has been under house arrest at the Sheshan Regional Seminary in a Shanghai suburb.

**Other information:** Joseph Liu Yuanlong, a vice chair of the CCPA, confirmed on 12<sup>th</sup> December 2012 that the government-sanctioned Catholic bishops' conference in China had revoked the appointment of Thaddeus Ma Daqin as auxiliary bishop of Shanghai, saying he violated the rules for Episcopal ordinations. A statement released by the Vatican on 13<sup>th</sup> December 2012 stated that even legitimately established and Vatican-recognized bishops' conferences "do not have the power to name or approve a bishop, to revoke his mandate or to impose sanctions on him."

**Fr. MA Wuyong, underground priest of the diocese of Baoding (Hebei)**

**Date and place of arrest:** August 2004, in the village of Suijiazhuang (Quyang County, Hebei)

**Charges:** He refused to join the *Chinese Catholic Patriotic Association*.

**Court decision:** Unknown

**Place of detention:** Prison of Qingyuan

**Other information:** Fr. Ma and eight other priests had gathered to celebrate their first year of ordination. Police arrived, carried out a door to door search and placed them under arrest. Before the Chinese New Year 2006, Fr. Ma was temporarily released from prison. He was re-arrested a month later, after attending the funeral of a priest of Baoding, Fr. Chen Baidu.

**Fr. SONG Wanjun**

**Age:** 39 years

**Place of residence:** Qiaodong District, Zhangjiakou City, Hebei Province

**Date and place of arrest:** 7<sup>th</sup> August 2013 in Qiaodong District, Zhangjiakou City, Hebei Province

3years

**Place of detention:** First place of detention was Qiaodong District to Zhangbei County

**Other information:** Fr. Song had evaded several arrests in the past from the Chinese Public Security until his current arrest.

**Fr. WANG Chengli, underground priest of the Diocese of Heze (Shandong)**

**Age:** 51 years

**Date and place of arrest:** 25<sup>th</sup> August 2011

**Charges:** He refused to join the *Chinese Catholic Patriotic Association*.

**Last court decision:** 2 ½ years of re-education through labour

**Place of detention:** First Dongming prison and then Jining concentration camp, over 150 miles from his county

**Msgr. WU Qinjing, official bishop of the diocese of Zhouzhi (Shaanxi)**

**Date and place of arrest:** November 2007

**Charges:** He refused to join the *Chinese Catholic Patriotic Association*.

**Court decision:** Unknown

**Place of detention:** Unknown

**Other information:** Since November 2007 Msgr. Wu has been kept under house arrest in the minor seminary in Xian with limits on his activities. Bishop Wu was secretly ordained as a bishop of the official diocese of Zhouzhi, without the permission of the local *Chinese Catholic Patriotic Association*. For this reason, since his ordination was made public in 2006, the government restricted his activities, kidnapped him and forced him to memorize the "Regulations on Religious Affairs." He is forbidden to carry the Episcopal insignia or carry out any activities as a bishop.

**Fr. ZHANG Jianlin, underground priest of the diocese of Xuanhua (Hebei)**

**Date and place of arrest:** He was taken away by the Religious Affairs Bureau on 22<sup>nd</sup> June 2011.

Since Orthodox Patriarch Antonios was forcefully deposed in 2007, 23 Orthodox priests are known to be still detained. Jehovah's Witnesses who were deprived of their citizenship after the ban of their movement in 1994 are also paying heavy tribute with over 70 long-standing prisoners.

## IRAN

The 2014 US Commission on International Religious Freedom (USCIRF) Report has published in an annex a list of 120 Baha'is, 48 Christians of various denominations, 14 Dervish Muslims and 88 Sunni Muslims in the list of religious prisoners serving prison terms in 2013.

*Human Rights Without Frontiers Int'l* is documenting below more than 100 individual cases of prisoners professing various faiths.

#### **Pastor Saeed ABEDINI**

**Statement of the defendant:** Managing the construction of a non-religious orphanage

**Articles of the criminal code:** Article 610 – Article 498 - Article 499

**Place of detention:** Rajai Shahr Prison

**Last court decisions:** 27<sup>th</sup> January 2013, eight years in prison for endangering national security by aiding underground Evangelical churches. On 25<sup>th</sup> August 2014, his appeal for a reduction of his sentence was rejected.

In March 2014, he was transferred to a private hospital in Iran after spending two months in a hospital for injuries allegedly suffered at the hands of guards and inmates. In

May, an armed contingent of Iranian guards stormed the hospital where he is detained and severely beat him.

Many prison terms are not known. One was sentenced to 12 years in prison, two to 10 years, two to 8 years, one to 7 years, 1 to 6 years, 10 to 5 years and many others to less than 5 years.

## SOUTH KOREA

### Jehovah's Witnesses

On 30<sup>th</sup> June 2014, 618 young Jehovah's Witnesses<sup>5</sup> were serving 18-month prison terms for conscientious objection to military service. From the Korean War period to the present, South Korea has repeatedly prosecuted young Jehovah's Witness men for their refusal to do military service. No provision is made for alternative service. Throughout this time, South Korea has sentenced 18,000 Jehovah's Witnesses to a combined total of 34,700 years in prison for their conscientious objection to military service.

**Charges:** Conscientious objection to military service

**Statement of the defendants:** Performing military service is incompatible with their faith.

**Last court decision:** Generally sentenced to 18 months in prison

**Article of the criminal/civil/administrative code or law:** Military Service Act Article 88 Paragraph 1

**Duration of detention:** Usually 18 months

**Other information:** Conscientious objectors who are called up as reservists face multiple prosecutions and repeated punishments over an eight-year period for violation of Homeland Reserve Forces Act, Article 15, Par. 9

The UN Human Rights Committee's decision on 1<sup>st</sup> December 2006 ruled that South Korea violated Article 18, paragraph 1, of the International Covenant on Civil and Political Rights. This decision found an infringement of freedom of conscience in the case of two Jehovah's Witnesses imprisoned for their conscientious objection to military service. On 24<sup>th</sup> March 2011, the Committee issued a similar ruling in the case of 100 other Jehovah's Witnesses; 438 other Jehovah's Witness complaints are still pending before this Committee. The Committee decisions remind South

Korea that it is in violation of this provision under international law. The government of South Korea has stated that it does not intend to implement the Committee's views.

## **FREEDOM OF EXPRESSION RELATED TO RELIGIOUS ISSUES**

### **Blasphemy, defamation of a religion, insulting religious beliefs**

Charges of “blasphemy,” “defamation of a religion” and “insulting religious beliefs” must be removed from the criminal code of countries which sentence to death or send to prison persons using their freedom of expression about religious issues.

The countries here listed are **Egypt, Indonesia, Pakistan, Saudi Arabia** and **Tunisia**.

## EGYPT

The Egyptian Initiative for Personal Right (EIPR) has documented 48 cases of vigilante harassment and judicial prosecution from January 2011 to the end of 2013. In some of these cases, customary sanctions were applied, while in others employers levied penalties.

In 28 of the cases, the issue reached a court of law. The number of these cases before courts increased from only three in 2011 to 12 in 2012 and 13 in 2013. Courts convicted 27 of 42 defendants tried on defamation charges.

Three defendants were acquitted and charges against 11 defendants were rejected due to lack of standing.

**Statement of the defendant:** Posting on Facebook (no details provided)

**First court decision:** On 22<sup>nd</sup> October 2011, he sentenced to three years in prison for deliberately insulting, attacking and mocking Islam on Facebook.

**Charges:** Blasphemy, defaming Islam and inciting riots

## **Tajul MULUK**

**Place of residence:** Sampang, East Java

**Charges:** Blasphemy and “causing public anxiety”

**Statement of the defendant:** Asserting that the current version of the Qu’ran is not the original one and questioning belief concerning the five pillars of Islam and six pillars of Islamic faith.

**Court decision:** Sampang district court sentenced him to two years in prison on the 12<sup>th</sup> July 2012.

**Article of the criminal/civil/administrative code or law:** Penal Code (KUHP) under Article 156a and the 1965 presidential decree against blasphemy by promoting a heretical interpretation of Islam

## **Christian**

### **Antonius Richmond BAWENGEAN**

**Age:** 62 years

**Place of residence:** Jakarta

**Date of Arrest:** 26<sup>th</sup> October 2010

**Charges:** Blasphemy

**Statement of the defendants:** Distributing pamphlets that allegedly disparaged the Kaaba.

**Court decision:** Sentenced to five years in prison on 8<sup>th</sup> February 2011

**Article of the criminal/civil/administrative code or law:** Penal Code (KUHP), Article 156(a)

**Other information:** Protesters demanded that Bawengan be handed over, and chanted “kill, kill” outside the court as he was led away under heavy security. The angry mob then trashed the courtroom before targeting Christian sites, burning down a number of churches and schools.

## PAKISTAN

The 2014 Annual Report of the U.S. Commission on International Religious Freedom had a list of prisoners<sup>7</sup> detained for alleged activities considered blasphemous or religiously insulting. Blasphemy laws carried in Section 295C of the Penal Code carries the death penalty in Pakistan. The use of this bylaw has creating an environment where some religious fanatics believe that they are entitled to take law into their own hands. There have been many instances where the local administration and police have either colluded with perpetrators or have stood by and done nothing to assist the accused, fearing the crowd. The use of the blasphemy law has become a quick way of resolving disputes arising from business rivalry, honour disputes, disputes over money and property. The accused are often lynched or languish for years in jail without trial because lawyers are too afraid to defend them. Judges have previously been attacked in Pakistan for acquitting blasphemy defendants and two politicians who discussed reforming the law were shot dead.

### **Death sentence**

#### **Christians**

##### **Muhammad ASGHAR (British Protestant)**

**Age:** 70

**Date of arrest:** September 2010 in the city of Rawalpindi

**Charges:** Blasphemy. He was accused of writing letters to several people claiming to be a prophet.

**Last court decision:** Sentenced to death in January 2014 by Rawalpindi court.

**Other information:** Asghar is from Edinburgh. His lawyers claimed that he had a history of mental illness in Scotland, but the court did not accept UK medical reports.

### **Qaisar AYUB**

**Age:** In his 40s

**Date and place of arrest:** He was arrested on 15<sup>th</sup> November 2014 in Lahore.

**Charges:** Blasphemy.

**Place of detention:** Unknown

**Duration of detention:** Unknown

**Other Information:** Qaisar is accused of posting blasphemous messages on a Christian website that he was moderating.

### **Asia BIBI (Protestant)**

**Age:** 37 years

**Place of residence:** Ittanwali

**Date of arrest:** 19<sup>th</sup> June 2009

**Charges:** Blasphemy

**Place of detention:** Central Jail in Multan

**Statement of the defendant:** She allegedly insulting the prophet Muhammad during an argument with some Muslim neighbors when she drank water from a well with an allegedly “unclean” cup used by Muslim women.

**Article of the criminal/civil/administrative code or law:** Section 295-C of Pakistan Penal Code

**First court decision:** Sentenced to death in November 2010

**Last court decision:** The Lahore High Court upheld the death sentence

**Other information:** When Bibi’s case came to prominence in 2010, three politicians – Salmaan Taseer, Shahbaz Bhatti and Sherry Rehman – all from the Pakistan People’s Party, which was then in power, took up the case and

called for reform. The consequences speak for themselves. Taseer was shot dead by his bodyguard in January 2011. In March the same year, Bhatti was killed by Taliban assassins. Rehman was forced into semi-hiding.

**Shafqat EMMANUEL, Shaguftah EMMANUEL (husband and wife) - Catholic**

**Age:** Shafqat (38) and Shaguftah (42)

**Place of residence:** Gojra

**Date of arrest:** 20<sup>th</sup> July 2013 in the city of Gojra

**Charges:** Blasphemy. They allegedly sent a text message in English deemed insulting to the Prophet Mohammed from their mobile telephone to an imam.

**Article of the criminal/civil/administrative code:** Filed by police, Section 295-B and 295-C of the Pakistan Penal Code and 25-D of The Telegraph Act of 1985.

**Statement of the defendants:** Shaguftah told the police that her cell phone had been lost for a month and that she did not know who could have sent the messages. The couple are not educated and unable to send messages in English.

**Place of detention:** Toba Tek Singh District Jail

**Last court decision:** Trial court in Toba Tek Singh on 4<sup>th</sup> April 2014 handed death sentence to the Christian couple.

**Other information:** With an intention of forcing them to confess, the police tortured Shafqat in front of his wife and four children. Their lawyer said that they would challenge the verdict in High Court. The legal team of the World Vision in Progress is defending the couple and taking care of their young children.

**Anwar KENNETH**

**Age:** 26 years

**Place of residence:** Karachi

**Date and place of arrest:** 2002



**Charges:** Anwar was accused of blasphemy when he distributed Christian literature and claimed to be a prophet.

**Statement of the defendant:** No statement.

**First court decision:** Sentenced to death.

**Other information:** Defendant was known to be suffering from mental health problems when the alleged offence occurred.

## **Savan MASIH**

**Age:** 26 years

**Place of residence:** Karachi

**Date and place of arrest:** Arrested in March 2013 in Karachi.

**Charges:** Sawan Masih was accused of blasphemy when he engaged in a dialogue with his Muslim friend.

**Article of the criminal/civil/administrative code:** Statue 295-C of the Pakistan Penal Code.

**Statement of the defendant:** Claimed that the complainant only filed a case as part of a ploy by a businessman to drive Christians away from the Colony they live in Karachi.

**First court decision:** Sentenced to death.

**Other information:** 180 Christian-owned homes and properties in Lahore's Joseph Colony were torched but a court later liberated 133 Muslim suspects.

## **Life imprisonment**

### **Masood AHMAD (Pakistani-British Ahmadi)**

**Age:** 72 years

**Date and place of arrest:** In 2013 in Lahore

**Charges:** Blasphemy

**Statement of the defendant:** He had read a verse from the Qu'ran during a religious discussion.

**Duration of the detention:** Over two months

**Date of release:** After three unsuccessful attempts in lower courts, a British-Pakistani national, Dr Masood Ahmad, has been granted bail by the Lahore High Court in Pakistan in January 2014.

**Other information:** Masood Ahmad, a homeopathy practitioner, has Pakistani-British dual citizenship.

### **Masqood AHMAD**

**Age/ Date of birth:** 52 years

**Place of residence:** District Narowal

**Date and place of arrest:** Arrested in Sambrial

**Charges:** Maqsood Ahmad was accused of blasphemy for throwing the Holy Qu'ran on the floor.

**Statement of the defendant:** According to Maqsood Ahmed he had prohibited his daughter from wearing makeup before reciting the Holy Qu'ran. He was also known for having disciplined his wife and daughter to have illicit relations with men residing in the same locality. Therefore, Maqsood Ahmad's wife and daughter became annoyed and accused Maqsood Ahmad of throwing the Holy Qu'ran to the floor.

**Article of the criminal/civil/administrative code:** Statue 295-C – of the Pakistan Penal Code.

**Place of detention:** Sahiwal Jail

**First court decision:** Sentenced to life imprisonment and the judge imposed him a fine of Rs. 20,000.

### **Rehmat ALI**

**Age:** 80 years

**Place of residence:** Mtala Colony

**Date and place of arrest:** Arrested in Mtala Colony.

**Charges:** Rehmat Ali was accused of blasphemy.

**Article of the criminal/civil/administrative code:** Statue 295-A & 295-B – of the Pakistan Penal Code.

**Place of detention:** District Jail, Faisalabad

**First court decision:** Sentenced to life imprisonment.

**Other information:** He is a psychiatric patient.

### **Imran GHAFOOR**

**Age:** 28 years

**Place of residence:** Hajavery Town, Faisalabad

**Date and place of arrest:** Arrested on July 1, 2009 in Faisalabad.

**Charges:** Imran Ghafoor was accused of burning the Holy Qu'ran and also some holy papers in front of his shop.

**Article of the criminal/civil/administrative code:** Statue 295-A&B – of the Pakistan Penal Code.

**Statement of the defendant:** The blasphemy allegations arose after business jealousy and rivalry because

Imran's business flourished whilst the accusers, Farayad Butt businesses were not doing so well.

**Place of detention:** Central Faisalabad prison.

**First court decision:** Sentenced to life imprisonment.

### **Abdul KAREEM**

**Age:** 24 years

**Place of residence:** Saddar Farooqabad

**Date and place of arrest:** Arrested on October 15, 2006 in Saddar Farooqabad.

**Charges:** Blasphemy.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** Claimed that the allegations of complainant (Mushtaq) for blasphemy were alleged to have taken place whilst he was in jail (false accusations). According to Abdul Kareem, Mushtaq was infuriated after being severely injured by Kareem and he wanted to take revenge on Kareem.

**Place of detention:** District Jail Sahiwal

**First court decision:** Sentenced to life imprisonment on June 21, 2007 with rigorous imprisonment.

### **Arif MAHDI**

**Age:** 32 years

**Place of residence:** District Multan

**Date and place of arrest:** 8<sup>th</sup> April 2006, Multan.

**Charges:** Arif Mahdi was accused of blasphemy as he found the Islamic booklets on the ground while he was painting a wall of the mosque.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** Claimed that the headman of the village (Malik Mehmood) took advantage of the situation and made a false accusation.

**Place of detention:** New Central Jail Multan

**First court decision:** Sentenced to life imprisonment on 20<sup>th</sup> October 2006.

### **Muhammad MUSHTAQ alias MASTA**

**Age:** 32 years

**Place of residence:** Multan

**Date and place of arrest:** Arrested in Makhdoom Rasheed.

**Charges:** Muhammad Mushtaq, was accused of disgracing the Holy Qu'ran.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code & 7 ATA.

**Statement of the defendant:**

**Place of detention:** New Central Jail Multan

**First court decision:** Sentenced to life imprisonment.

### **Inayat RASOOL**

**Age:** 27 years

**Place of residence:** Zafarwal in Shakargarh Tehsil

**Date and place of arrest:** 23<sup>th</sup> June 2006, Zafarwal Narowal.

**Charges:** Inayat Rasool was accused of desecrating the Holy Qu'ran by throwing the Holy Qu'ran into the canal.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** He was attending a carnival of Chanpeer and on his way home while crossing a canal bridge, he saw some pages of Holy Qu'ran in the dirty water.

**Place of detention:** District Jail Sahiwal

**First court decision:** Sentenced to life imprisonment with rigorous imprisonment on 29<sup>th</sup> December 2008.

## **Muhammad SAFDAR**

**Age:** 51 years

**Place of residence:** Kabirwala, District Khanewal

**Date and place of arrest:** 1<sup>st</sup> October 2010 in Kabirwala, Khanewal.

**Charges:** Muhammad Safdar was accused of blasphemy.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** Safdar's wife had a dispute with the wife of Muhammad Abdullah, a neighbour of Muhammad Safdar. That led Muhammad Abdullah to falsely accuse him of blasphemy.

**Place of detention:** New Central jail Multan

**First court decision:** Sentenced to life imprisonment with rigorous imprisonment on 17<sup>th</sup> January 2011.

## **Muhammad SHAFI**

**Age:** 58 years

**Place of residence:** Muzaffar Garh

**Date and place of arrest:** Arrested in Dera Deer Panah.

**Charges:** Muhammad Shafi, was accused of blasphemy because he removed a poster with printed verses of the Holy Qu'ran and of trampling it with his foot.

**Place of detention:** New Central Jail Multan

**First court decision:** Sentenced to life imprisonment and the judge imposed him a fine of Rs. 230,00 in the instance that the fine cannot be paid a sentence of two years imprisonment is to be made.

### **Muhammad SHAHZAD**

**Age:** 32 years

**Place of residence:** College Road, Gujranwala.

**Date and place of arrest:** Arrested in Garjakh-Gujranwala.

**Charges:** Muhammad Shahzad was accused of blasphemy.

**Statement of the defendant:** He was working at his mil shop when he saw Mouhammad Yousaf, a mentally ill individual burning the Holy Qu'ran so he rushed to stop him but before he arrived, Yousaf had already burnt the Holy Qu'ran. Shahzad later took the burnt pages and tried to rescue others from the flames but people who saw him, mistakenly assumed that he was an accomplice.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**First court decision:** Sentenced to life imprisonment on 18<sup>th</sup> January 2011.

### **Shamas UD DIN**

**Age:** 35 years

**Place of residence:** Gondal Ghari, Sialkot

**Date and place of arrest:** Arrested in Marala.

**Charges:** Shamas Ud Din was accused of blasphemy.

**Statement of the defendant:** He was running a shop selling artificial jewelry in the main market of Sialkot city. One of his friends, who had applied for a loan from the bank in order to buy land, asked Shamas to act as a witness in order to obtain a loan. Shamas discovered that his friend and the bank

manager had colluded together to obtain fraudulently loans getting innocent uneducated bank account holders as witnesses. Shamas wrote a letter to the bank manager in which he explained that their act was against Qu'ran and Sunnah. He also wrote a letter to the head of the mosque requesting him to teach the scriptures to the bank manager and to discipline him because his acts were against Qu'ran and Sunnah. But Shama's friend changed the original letter into a blasphemous one.

**Article of the criminal/civil/administrative code:** Statue 295-A & 295-C – of the Pakistan Penal Code.

**Place of detention:** District Jail Sahiwal

**First court decision:** Sentenced to life imprisonment on 5<sup>th</sup> June 2010 and the judge imposed him a fine of Rs. 150,000, in the event that the fine was not paid a further sentence of one year's imprisonment was imposed.

**Other information:** He is the father of 3 children. He has developed psychiatric problems.

## **Muhammad YOUSAF**

**Age:** 50 years

**Place of residence:** Gujranwala

**Date and place of arrest:** 24<sup>th</sup> March 2003 in Garjakh-Gujranwala on.

**Charges:** Muhammad Yousaf was accused of blasphemy as he burnt the Holy Qu'ran.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Place of detention:** Sahiwal Jail

**First court decision:** Sentenced to life imprisonment on 18<sup>th</sup> January 2011.

**Other information:** He is mentally ill.

## **Asif**

**Age:** 31 years

**Place of residence:** Village of Machikay in Gujranwala.

**Date and place of arrest:** 18<sup>th</sup> June 2006 in Ferozewala, Gujranwala.

**Charges:** Asif was accused of burning the pages of Holy Qu'ran.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** Claimed that he was burning waste papers and mistakenly a few pages of the Holy Qu'ran were also burnt.

**Place of detention:** District Jail Sahiwal

**First court decision:** Sentenced to life imprisonment with rigorous imprisonment on 31<sup>st</sup> January 2008.

**Other information:** He is currently mentally ill.

## **Imran**

**Age:** 26 years

**Place of residence:** Faisalabad

**Charges:** Imran was accused of blasphemy after a property dispute.

**Article of the criminal/civil/administrative code:** Statue 295-B – of the Pakistan Penal Code.

**Statement of the defendant:** He has psychiatric problems.

**Place of detention:** District Jail Faisalabad

**First court decision:** Sentenced to life imprisonment.

# **SAUDI ARABIA**

## **Muslim**

### **Raif BADAWI**

**Age:** 1984

**Date and place of arrest:** 17<sup>th</sup> June 2012

**Charges:** Apostasy and setting up a website that undermines general security and ridiculing Islamic religious figures



**Statement of the defendant:** Raif stated that Muslims, Jews, Christians and atheists are all equal. He claims he never attacked Islam and that he only sought to provide a forum for open debate.

**First court decision:** On 29<sup>th</sup> July 2013 Badawi was sentenced to 600 lashes and seven years in prison. An additional three months was added for ‘parental disobedience’.

**Last court decision:** On 7<sup>th</sup> May 2014, Badawi was re-sentenced to 1000 lashes and ten years in prison. He also received a fine of 1 million riyal (equal to about \$267,000).

**Other information:** Raif was first sentenced for violating IT law and insulting Saudi Arabia’s Committee for the Promotion of Virtue and Prevention of Vice through his online writings and hosting those of others on the “Free Saudi Liberals” website.

## TUNISIA

### Muslim

#### Jabeur MEJRI

**Date and place of arrest:** 5<sup>th</sup> March 2012

**Charges:** Transgressing morality, defamation and disrupting public order

**Statement of the defendant:** Published caricatures of the Prophet Mohammed, including one in which he was naked and one which portrayed a pig sleeping on the Kaaba

**First court decision:** On 28<sup>th</sup> March 2012 a primary court in Mahdia sentenced him to seven and a half years in prison and a fine of 1200 Tunisian Dinars (≈USD \$800).

**Last court decision:** On 25<sup>th</sup> April 2013 the Court of Cassation upheld his sentence.

**Article of the criminal/civil/administrative code or law:** Article 121 (3) and 226 of Penal Code

**Date of release:** 4<sup>th</sup> March 2014, presidential pardon

## **Human Rights Without Frontiers Int'l recommendations to the EU**

Considering that on 24<sup>th</sup> June 2013, the Council of the European Union adopted the Guidelines on the Promotion and Protection of Freedom of Religion or Belief, committing the EU to:

- recall at all appropriate occasions that laws that criminalize blasphemy restrict expression concerning religious or other beliefs; that they are often applied so as to persecute, mistreat or intimidate persons belonging to religious or other minorities, and that they can have a serious inhibiting effect on freedom of expression and on freedom of religion or belief; and recommend the decriminalization of such offences.
- Forcefully advocate against the use of the death penalty, physical punishment, or deprivation of liberty as penalties for blasphemy.

*Human Rights Without Frontiers* recommends to all EU institutions to develop strategies aiming at the removal of any law criminalizing freedom of expression, in particular with regard to religious issues.
